Scientific Council

Scientific Council of the Institute of the History of Charles University and Archive of Charles University PhDr. Daniela Brádlerová, Ph.D.

Born in 1971, Brádlerová graduated in archival science and auxiliary historical sciences at the Faculty of Arts of Charles University (1996) and completed her post-graduate studies in the history of economy at the same institute (2005). She is currently employed by the Masaryk Institute and Archive of the Academy of Sciences of the Czech Republic (head of the Department of Institutional Funds after 1952). Her research and publications focus on the history of Czechoslovak scientific institutions and notable personages of science in the 20th century. She is also interested in the history of banking in interwar Czechoslovakia and military history of the First World War.

Mgr. Petr Cajthaml

Born in 1974, Cajthaml graduated in history with specialisation in Czech history at the Faculty of Arts of Charles University (1998). He is currently employed by the Institute of the History of Charles University and Archive of Charles University (head of Archive of Charles University). His research and publications focus on the history of university education, history of propaganda, and the history of Czechoslovak intelligence services.

Born in 1950, Čornejová graduated in archive science and history at the Faculty of Arts of Charles University (1973). She did her first post-graduate degree (aspirantura) at the Faculty of Arts of Charles University (1988) and received her habilitation at the Faculty of Social Sciences of Charles University (1999). She is employed by the Institute of the History of Charles University and Archive of Charles University. Her research and publication focus on Czech and Church history of the 16th to 18th century, history of schooling and education, history of administration, and cultural history of the Baroque period.

PhDr. Marek Ďurčanský, Ph.D.

Born in 1973, Ďurčanský graduated in history and archival science at the Faculty of Arts of Charles University (1999) and completed his post-graduate studies in auxiliary historical sciences at the same faculty (2007). He is currently employed by the Institute of the History of Charles University and Archive of Charles University (head of the Institute of the History of Charles University). His research and publications focus on the history of university education, cultural and administrative history of Czech towns and cities in Early Modern Era and Modern Era, and on Czech–Polish scientific and cultural relations.

prof. PhDr. Ivan Hlaváček, CSc.

Born in 1931, Hlaváček graduated in archival science and auxiliary historical sciences at the Faculty of Arts of Charles University (1955). At the same faculty, he also received his habilitation in archival science and auxiliary historical sciences (1967) and was named professor for the same area of specialisation (1990). He works at the Department of Auxiliary Historical Sciences and Archival Studies of the Faculty of Arts of Charles University. His research and publications focus on medieval diplomacy, codicology, epigraphy, and political, administrative, and cultural history of Late Middle Ages.

Mgr. Jan Kahuda, Ph.D.

Born in 1974, Kahuda graduated in archival science and history at the Faculty of Arts of Charles University (1999). He is currently completing his post-graduate studies in auxiliary historical sciences at the same faculty (since 2007). He is

employed by the National Archives (since 2014 head of department). His research and publications focus on the history of archival science, family archives, auxiliary historical sciences, history of administration, and editions of source materials.

PhDr. Kamila Mádrová, Ph.D.

Born in 1985, Mádrová graduated in archival science and auxiliary historical sciences at the Faculty of Arts of Charles University (2010) and completed her post-graduate study in General History at the same faculty (2015). Since 2015 she is employed in Czech Technical University Archive and since 2017 works as its head. Her research and publications focus on the history of Habsburg Empire in the 2nd half of the 19th century, history of education and history of universities with emphasis on CTU and its predecessors.

prof. PhDr. Jiří Pešek, CSc.

Born in 1954, Pešek graduated in archival science and auxiliary historical sciences at the Faculty of Arts of Charles University (1978). He completed his first post-graduate degree (aspirantura) at the institute of Czechoslovak and World History of the Czechoslovak Academy of Sciences (1987). prof. PhDr. Jiří Pokorný, CSc.

Born in 1957 in Prague, Pokorný completed his studies in the archival science and history in 1982. He has worked at All Unions Archive (1982-1988), Czech Technical University Archive (1988-1991), Institute of History (1991-1993), Faculty of Education (1993 up to the present time) and All Unions Archive (1996 up to the present time). His research and publications focus on the Czech modern history and history of education.

doc. PhDr. Marie Ryantová, CSc.

Born in 1964, Ryantová graduated in archival science and auxiliary historical sciences at the Faculty of Arts of Charles University (1886). She received her post-graduate degree (aspirantura) in older Czech history at the Institute of Czech History of the Faculty of Arts of Charles University (1995) and her habilitation at the Institute of History of the University of South Bohemia in České Budějovice (2005). She is currently employed by the Faculty of Philosophy of the University of South Bohemia in České Budějovice (head of the Institute for Archival Studies and Auxiliary Historical Sciences). Mgr. Jan Schwaller

Born in 1974, Schwaller graduated in history, archival science, and auxiliary historical sciences at the Faculty of Arts of Charles University (1998). He is currently employed by the Prague City Archives (head of the Department of Funds of Municipal Companies, Institutions, and Physical Persons). His research and publications focus on the economic, social, and regional history of 16th to 18th century.

prof. PhDr. Petr Svobodný, Ph.D.

Born in 1958, Svobodný graduated in history at the Faculty of Arts of Charles University (1981).
